- 4. Reports from Commissioners and City Staff (No Action to Be Taken)
 - A. Mayor-Erik Premont: Had a budget meeting today and will have one on the 27th to vote on the recommendations made by the tax assessor of Fannin County. The meeting will be held next Tuesday at 5:00 PM. All other items will be on the other line items.
 - B. Mayor Pro Tem-Claude Lewis, Jr.: All my items will be under other line items.

 - D. City Secretary-Pat Patterson (activities and information): We did not go over budget, but actually, stayed under budget. We actually saved some money so that we can use it to repair the roads. Her name is Shei Watkins and she lives in Savoy. There has been a lot of dumping on this property which affects the neighbors behind it.

Streetlights and need to pull the one at Ed Cater's house. Need to pull the one at Cherry and E. Sycamore. Power is disconnected at the pole at the Farmer's Market.

Tree trimming. Some down Red Bud and Willow.

Still trying to find someone to work for the city.

Got a Marque for free. Have some minor repairs to be done, but will very good. Six ft tall and eight ft wide.

Citizen suggested that the road worker that trim trees could perhaps trim in the city for a fee. This would help with getting the roads grated.
